

Comparison of Form 8938 and FBAR Requirements

The Form 8938 filing requirement does not replace or otherwise affect a taxpayer's obligation to file FinCEN Form 114 (Report of Foreign Bank and Financial Accounts). Unlike Form 8938, the FBAR (FinCEN Form 114) is not filed with the IRS. It must be filed directly with the office of Financial Crimes Enforcement Network (FinCEN), a bureau of the Department of the Treasury, separate from the IRS.

Individuals and domestic entities must check the requirements and relevant reporting thresholds of each form and determine if they should file Form 8938 or FinCEN Form 114, or both. Specified domestic entities: Total value of assets was more than \$50,000 on the last day of the tax year, or more than \$50,000 at any 	<p>Aggregate value of financial accounts exceeds \$10,000 at any time during the calendar year. This is a cumulative balance, meaning if you have 2 accounts with a combined account balance greater than \$10,000 at any one time, both accounts would have to be reported.</p>

<p align="center"><i>How are maximum account or asset values determined and reported?</i></p>	<p align="center">Fair market value in U.S. dollars in accord with the Form 8938 instructions for each account and asset reported</p> <p align="center">Convert to U.S. dollars using the end of the taxable year exchange rate and report in U.S. dollars.</p>	<p align="center">Use periodic account statements to determine the maximum value in the currency of the account.</p> <p align="center">Convert to U.S. dollars using the end of the calendar year exchange rate and report in U.S. dollars.</p>
<p align="center"><i>When Due?</i></p>	<p align="center">Form is attached to your annual return and due on the date of that return, including any applicable extensions</p>	<p align="center">Received by April 15 (6-month automatic extension to Oct 15)</p>
<p align="center"><i>Where to File?</i></p>	<p align="center">File with income tax return pursuant to instructions for filing the return.</p>	<p align="center">File electronically through FinCEN's BSA E-Filing System. The FBAR is not filed with a federal tax return.</p>
<p align="center"><i>Penalties</i></p>	<p align="center">Up to \$10,000 for failure to disclose and an additional \$10,000 for each 30 days of non-filing after IRS notice of a failure to disclose, for a potential maximum penalty of \$60,000; criminal penalties may also apply</p>	<p align="center">Civil monetary penalties are adjusted annually for inflation. For civil penalty assessment prior to Aug 1, 2016, if non-willful, up to \$10,000; if willful, up to the greater of \$100,000 or 50 percent of account balances; criminal penalties may also apply</p>
